Stolen Mail Update by Randy Carroll

There have been a few residents in the Chuckanut Bay Community that have been victims of mail theft.

The perpetrator has been arrested, as has his wife. Unfortunately, the individual is out of jail awaiting sentencing. It is anticipated that he will be returned to prison to serve a two-year sentence on an unrelated parole violation. This return to prison and his length of stay is more incarceration than he would have received on any conviction for theft of mail. We are not alone in this perpetrators victimization. He was/is a thief of opportunity and wanders Whatcom County taking mail from mailboxes when he is relatively certain no one is watching or, there is little to no activity in the neighborhood. He steals mail looking for opportunities to convert the contents of mail to his gain. That is to say, if he finds a check in the stolen mail, he will 'wash'* the check and make it out to himself. He will look for mail with credit cards and use them and then sell them. When he can he will take the information he finds in the mail and steal identity. His wife is his accomplice and she is currently in jail awaiting trial for possession of stolen property, aiding and abetting theft, and drug charges.

The issue of mail theft was addressed at a neighborhood meeting that was organized to discuss train noise in the neighborhood. This issue was something that came up as a side topic.

Many drug addicted/dependent individuals often steal mail. It is easy to do and usually goes undetected until the victim realizes that financial accounts have been accessed. That is, charges to a credit card that were not made by the account holder, or withdrawing of money from bank accounts not by the account holder, or in some cases new credit cards are ordered by the thief in the victims name and the victim is unaware until a collection agency calls for non payment. In extreme cases 'big ticket items' have been purchased, such as boats and cars, and in rare cases mortgages have been taken out, property purchased and sold in the victims name with assets being gained by the thief whom is thought to be the victim because the thief has assumed the identity of the victim. Gangs or a very organized group usually accomplishes these extreme cases.

What we have experienced is a thief looking to support a drug habit...... small time...... but still someone creating victims. Crime Prevention experts have advised people not to put outgoing mail in an outside mailbox, especially one that is roadside, and to never put mail in the box and then raise the red flag for pick up. This is an open invitation to a thief. Crime Prevention folks also recommend installing locking mailboxes if residents want to receive mail at or near their homes. The best option is a Post Office Box. Granted, it is an expense and sometimes not convenient but, it is a very secure way to receive mail.

The residents throughout the county whose mail was recovered in the perpetrators house have been contacted by Bellingham Police. BPD recovered the mail while investigating another crime at the perpetrators residence and seeing piles of mail that were not addressed to the arrestee. It was discovered that many residents in the city and county were victimized (around 200).

As stated earlier some residents of the neighborhood expressed concern over this situation and there was a commitment to follow up and obtain information. If there are further concerns this topic can be discussed at one of the Association meetings.

Please reconcile your bank statements, credit card statements and other financial accounts monthly. Additionally, everyone should run a credit history check on themselves through the three major credit bureaus to determine if there are accounts open in your name that you have no knowledge of. Your personal banker may assist you in doing this.

* Applying a chemical solution to the ink on the line 'Pay to the Order of', and removing the intended recipients name is 'Washing' a check. The thief then writes or types a different name on that line and cashes the check, or has someone cash it. (Easy to do when you have stolen many, many pieces of mail and have many pieces of identification not in your real name.)
