I believe his joy in growing his own vegetables led him to work to make Haggens sell only the freshest and most delectable produce in town. I will miss him greatly.

# Ray Giesecke

A native of North Dakota, Ray was working with the Civilian Conservation Corps when World War II broke out. He joined the army and served for 23 years, working his way up to Lt. Col. He and his wife, Dorothy Jane, moved into their Chuckanut home in the early 1960s. He was working for Whatcom County Parks Department as Deputy Director and was instrumental in the development of the county parks residents enjoy today. He was widowed in 1969. When he remarried, he and Dorothy continued to enjoy living on Pleasant Bay Road, where they were friends and neighbors of my parents. Ray was part of the Chuckanut Volunteer Firefighters for many years. He served as treasurer, secretary and president. He died at the age of 93 on August 17, 2011. He was a long time active Chuckanut neighbor.

# **History** by Lynnette Berry

The Interurban trail is widely used by many in the community, but few of us can name and identify each station stop between Bellingham and Mt. Vernon. The freight and passenger service ran from 1912 through 1928 (freight service through 1931) and linked Whatcom and Skagit counties with an electric train line. There was an electric substation at Clayton Bay to provide power to the line operated by a maintenance worker who lived at the substation. Locals referred to the Interurban as "Auntie Urban" which served as the school bus of the early days. Many youngsters would run to their station stop along the route at the sound of its whistle in the morning. The all steel cars had hourly service, carried up to 75 passengers and reached speeds of up to 65 miles an hour! At each station stop was a building about 12 feet square where passengers could keep out of the rain and weather. These stations each had a name which was displayed by a sign mounted on the building.

Service discontinued in 1928, unable to compete with automobiles, buses and trucks, plus wrecks, maintenance problems and economics of the times. The tracks were torn up and the substation at Clayton Bay dismantled. By the 1970's the trail had become overgrown and muddy. Whatcom County Parks Department in cooperation with Puget Power, Bellingham City Parks and Larrabee State Park developed a plan for joint management and the county Commissioners declared it off limits to motor vehicles.

The original **Bellingham Station** was located in the Pike Building (long since torn down) on the corner of State and Holly. It later moved to a building across from the Copper Hog where an espresso stand now exists. The first stop on the line was **South Bellingham-I** am guessing near Fairhaven.

Next was **North High Bridge Station** on the north side of the high bridge which crossed over Old Samish Road and Chuckanut Creek. This station was for Happy Valley and Old Samish road residents. (You can still see the bridge pillars north and south of Old Samish Highway on the Trail.) The original high bridge was 700 feet long and 130 feet above the creek. The highest sea-level point on the route, the bridge was built with the labor of 150 men. This old timbered span was replaced in 1925 with steel.

After that came **South High Bridge** on the south end of the high bridge to serve the people living in Chuckanut Village and on Chuckanut Mountain. Hikers would get off here where the trail to the mountain top began right at the station stop.

Following that was **Inspiration Point** at the south city limits of Bellingham. This stop served the people working at the Coast Brick and Tile Company which was located next to the water at what is now known as Teddy Bear Beach.

The next stop was **Grandview** which was located above the Roth stone quarry and served the quarry and also the Astoria Puget Sound Salmon Cannery.

After that came **Camp Perfection** which served the campers at Camp Perfection and the residents of Finn Beach and was located about half way along the route between the two places. The trail from the highway to the station was just across the highway from the residence at 857 Chuckanut.

Followed by the stop at **Wildcat Cove**, right in front of 606 Chuckanut Dr. This stop was where the trail began which lead over to the Fairhaven Boy's Club cabin and camp area located on Governor's Point.

**Larrabee Park** was next and was just above the original park caretaker's residence. The old house, which was a log cabin, has since been torn down and all that remains is the stone fire place.

**Clayton Bay** came next at the Whatcom-Skagit County line where Puget Sound Power and Light Company maintained a power substation and where the two families who tended it, lived.

From there, the Interurban ran across a long trestle over Samish Bay to Blanchard. Along the trestle there was a stop at a place called **Seawood** about three quarters of a mile north of Oyster Creek. This was where the Hountoon Oyster Company was located and was also the summer home of the C.X. Larrabee family.

There was another stop along the trestle and that was at the **Rocky Point** Oyster Company about a half mile south of Oyster Creek and directly below the Oyster Bar.

The sawmill and logging town of **Blanchard** was the next stop, after it came **Bow**, **East Edison**, **Allen** and **Burlington** and the final stop and turn around was **Mt. Vernon**.
